Special Additional Conditions:

The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

Additional Conditions:

1. The unit shall treat and dispose the sewage generated from the unit through septic tank followed by soak pit.

2. The unit shall ensure that no trade effluent is generated from its manufacturing activity.

3. The unit shall adhere to the Plastic Waste Management Rules, 2016.

4. The unit shall ensure that Carry bags made from compostable plastics shall conform to the Indian Standard: IS 17088: 2008 titled as Specifications for Compostable Plastics, as amended from time to

5. The unit shall not manufacture products banned in the G.O.(Ms) No. 84 dated 25.06.2018 & G.O.

Ms. No. 37 dated 05.06.2020 issued by Government of Tamilnadu.

6. The unit shall properly collect and dispose the non-hazardous solid wastes for the further beneficial use without any accumulation inside the unit premises.

7. The unit shall not carry out manual cleaning of Septic tank under any circumstances.

8. The unit shall comply with the conditions stipulated in Provisional certificate to manufacturer for marketing and selling of compostable carry bags / Products issued by CPCB, Ministry of Environment, Forest and Climate Change, Govt. of India to the unit vide Certificate No. B-17011/7/PWM(COMP)/2020(KP)/5251 dated: 21.08.2020.

9. The unit shall not use "Use and throwaway plastics" irrespective of thickness such as plastic sheets

used for food wrapping, spreading on dining etc; plastic plates, plastics coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags within the premises. Instead the unit shall encourage use of eco-friendly alternatives such as banana leaf, Arecanut palm plate, stainless steel, Glass, Porcelain plates/cups, Cloth bag, Jute bag etc.
